- **Fees and Payment: Stud Fees (CAD, subject to GST):**

- Nesquick TN – \$1,250 (\$1,312.50 incl. GST)
- O'Connor – \$1,250 (\$1,312.50 incl. GST)
- Skyline TN – \$1,250 (\$1,312.50 incl. GST)
- Grand Turismo – \$1,000 (New for 2026; \$1,050 incl. GST)

**Early Bird Discount - payment in full by April 1**

**Black Friday, take off another 5% - payment in full by December 31, 2025**

- Nesquick TN – \$1,125 (\$1,181.25 incl. GST)
  - O'Connor – \$1,125 (\$1,181.25 incl. GST)
  - Skyline TN – \$1,125 (\$1,181.25 incl. GST)
  - Grand Turismo – \$900 (\$945 incl. GST)
- **Collection Fees:** First collection and shipping container included. Additional collections: \$300 + \$45 container (\$345 + GST).
  - **Shipping Fees:** Courier charges at cost. Airline shipments: \$250 delivery fee + COD.
  - **Payment Methods:** E-transfer (to [lorrie@elysianfarm.ca](mailto:lorrie@elysianfarm.ca), include stallion and contract name), cash, cheque, or credit card (authorization form required).

**No semen will be shipped unless payment in full has been received.**

### **3. Live Foal Guarantee**

- A “live foal” is defined as one that stands and nurses within 4–8 hours of foaling.
- Mare Owner must maintain appropriate nutrition, veterinary care, and body condition throughout gestation.
- In the event of a dead foal, notification must be made within 24 hours and a veterinary certificate provided.
- If conditions are met, Mare Owner is entitled to a return breeding within two breeding seasons.
- If Stallion dies, is sold, or becomes unfit, Mare Owner may substitute another stallion at Elysian Farm.
- If Mare dies or becomes unfit, substitution of another mare may be permitted with mutual agreement.

#### 4. Mare Care (On-Site)

- Mare must be current on vaccinations (Flu, Rhino, West Nile, Tetanus, EEE, WEE).
- Current Coggins Test required (available on-site at \$120).
- Veterinary or farrier services are at Mare Owner's expense.
- Emergency care: Elysian Farm is authorized to contact Alberta Veterinary Center and follow their advice.

#### Boarding Rates:

- Outdoor dry, small group: \$18/day
- Outdoor wet/individual: \$25/day, if available
- Indoor board, individual turnout/hotwalker: \$35/day

Discounts available for multiple mares, repeat clients, and performance horses.

#### 5. Liability Waiver

Elysian Farm, its owners, employees, veterinarians, and guests shall not be liable for injury, escape, disability, or death of any horse on its premises, except in cases of gross negligence or willful misconduct.

#### 6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Province of Alberta and the laws of Canada applicable therein.

#### 7. Entire Agreement

This Agreement constitutes the entire understanding between the Parties and supersedes all prior agreements, whether verbal or written. Amendments must be in writing and signed by both Parties.
